Pettis County R-5 School District

Proposition Mustangs

4/7th Vote Majority

Shall the Board of Education of the Pettis County R-V School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of One Million Five Hundred Thousand Dollars (\$1,500,000) for the purpose of providing funds to complete safety and security upgrades; install new heating, ventilation, and air conditioning (HVAC) systems; replace roofs; to the extent funds are available, complete additional repairs and renovations to the existing facilities of the District; and issue bonds for the payment thereof?

(If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.4955 per one hundred dollars of assessed valuation of real and personal property.)

Shall the City of Windsor impose a local use tax at the same rate as the total local sales tax rate, currently one and three-quarters percent (1.75%), provided that if the local sales tax rate is reduced or raised by voter approval, the local use tax rate shall also be reduced or raised by the same action? A use tax return shall not be required to be filed by persons whose purchases from out-of-state vendors do not in total exceed two thousand dollars in any calendar year.

4/7th Vote Majority

Shall the Board of Education of the Cole Camp R-I School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Two Million Five Hundred Thousand Dollars (\$2,500,000) for the purpose of providing funds to complete renovation, remodeling and repair improvements District-wide to include, without limitation, plumbing, electrical, and roofing upgrades; heating, ventilation and air conditioning system (HVAC) replacement; restroom remodeling; playground improvements; to the extent funds are available, construct a new all-weather track; and issue bonds for the payment thereof?

If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.62 per one hundred dollars of assessed valuation of real and personal property.
